Since 2003, the Illinois Law Enforcement Training and Standards Board (ILETSB) has provided state-certified Crisis Intervention Team (CIT) training to law enforcement officers throughout Illinois. Participants of this one week / 40 hour block of instruction receive intensive training on dealing with individuals in the community who have a mental illness or other behavioral disability. To date, the ILETSB has certified over 4300 officers statewide, from more than 280 agencies in this specialized program.
