The **Oregon Sexual Assault Task Force** along with their Illinois partners, the **Illinois Attorney General** and **Illinois Law Enforcement Training and Standards Board**, are pleased to present this **free** training for law enforcement on non-stranger sexual assault response and sex offender interviewing and interrogation.

Day 1: Non-Stranger Sexual Assault Response & Investigation

The *Non-Stranger Sexual Assault Response & Investigation* training provides basic and intermediate information on sexual assault dynamics, law enforcement response, preliminary investigation, victim interviewing and evidence collection and use. This training develops officers' core skills and knowledge related to sexual assault response and investigation.

Day 2: Identifying Sex Offenders: Tools for Interview & Interrogation

Identifying Sex Offenders: Tools for Interview and Interrogation provides law enforcement with current research on sex offender typologies within the context of identifying the most effective strategies for interviewing and investigation. This training is ideal for law enforcement officers who have experience investigating sexual assault.

Advanced Workshops: Crime Scene Response & Victim Interview

Crime Scene Investigation & Victim Interview is geared towards officers who have experience in investigating sexual assault. The two advanced activities provide law enforcement with interactive, simulated experience in evidence collection, documentation, photography, techniques for using technology and social media, building rapport with victims, overcoming victim credibility challenges, and interview techniques.

Day 3: Train-the-Trainer (Optional)
